

Motion to Vacate, Set Aside, or Correct a Sentence

By a Person in Federal Custody

(Motion Under 28 U.S.C. § 2255)

Instructions

- To use this form, you must be a person who is serving a sentence under a judgment against you in federal court. You are asking for relief from the conviction or the sentence. This form is your motion for relief.
- You must file the form in the United States District Court that entered the judgment that you are now challenging. If you want to challenge a federal judgment that imposed a sentence to be served in the future, you should file the motion in the federal court that entered that judgment.
- Make sure the form is typed or neatly written.
- You must tell the truth and sign the form. If you make a false statement of a material fact, you may be prosecuted for perjury.
- Answer all the questions. You do not need to cite law. You may submit additional pages if necessary. If you do not complete the form properly, you will be asked to submit additional or correct information. If you would like to submit a brief or any additional arguments, you must submit them in a separate memorandum.
- If an attorney, who has access to the Court's Electronic Filing System, is filing on your behalf, your motion must be submitted in hard copy (paper format) to the Clerk's Office and not filed electronically primarily because at the filing of your motion, a new civil case is generated, but only as a shell case. The motion is then treated as a pending motion in the closed criminal case.
- In this motion, you may challenge the judgment entered by only one court. If you want to challenge a judgment entered by a different judge or division (either in the same district or in a different district), you must file a separate motion.

- If you want a file-stamped copy of the motion, you must enclose an additional copy of the motion and self-addressed stamped envelope and ask the Court to file-stamp it and return to you.

CAUTION: You must include in this motion ALL grounds for relief from the conviction or sentence that you challenge. And you must state facts that support each ground. If you fail to set forth all the grounds in this motion, you may be barred from presenting additional grounds at a later date.

CAPITAL CASES: If you are under a sentence of death, you are entitled to the assistance of counsel and should request the appointment of counsel.

* The Antiterrorism and Effective Death Penalty Act of 1996 (“AEDPA”) as contained in 28 U.S.C. § 2255, paragraph 6, provides in part that:

A one-year period of limitation shall apply to a motion under this section. The limitation period shall run from the latest of –

- (1) the date on which the judgment of conviction became final;
- (2) the date on which the impediment to making a motion created by governmental action in violation of the Constitution or laws of the United States is removed, if the movant was prevented from making such a motion by such governmental action;
- (3) the date on which the right asserted was initially recognized by the Supreme Court, if that right has been newly recognized by the Supreme Court and made retroactively applicable to cases on collateral review; or
- (4) the date on which the facts supporting the claim or claims presented could have been discovered through the exercise of due diligence.
